Equality Impact Assessment: Proposal for removal of funding for Citizens Advice Woking 2024/2025

1. Introduction

This Equality Impact Assessment (EqIA) seeks to identify impacts and effect of this proposal with the aim of assessing whether it would have a disparate impact on persons with a protected characteristic under the Equality Act 2010. As part of this assessment, consideration will be given to ways in which any such impact can be avoided or mitigated, any negative impacts arising from this proposal will be assessed and where this could be reduced in their impact this will be noted in the attached action plan. The Council also recognises that it may not completely remove all negative impacts.

The purpose is to provide impartial information to assist in the decision-making process and inform rather than determine policy. The objective is not to make the decision but to assist decision makers through the provision of relevant information.

The Council faces a critical financial shortfall owing to its historic investment strategy which has resulted in unaffordable borrowing, inadequate steps to repay that borrowing and high values of irrecoverable loans.

To address these severe financial challenges the Council must make significant saving alongside taking steps to 'live within its means' in the future.

Widespread reductions and changes to public-facing services, alongside reducing management and internal costs, have been set out in the <u>Council's Medium</u> <u>Term Financial Strategy</u>.

This Equality Impact Assessment covers the exercising of the break clause in the Service Level Agreement and removal of £265,750 grant funding to the Citizens Advice Woking (CAW) as part of the Council's withdrawal of all discretionary community grants from 2024/25. Funding from Woking Borough Council (WBC) represented 51% of Citizens Advice Woking's total income in 2022/23 (including Household Support Funding). CAW does not pay rent to WBC for the use of their office space at Provincial House, which has a rateable value of £41,250 and is not included in the amount above.

Although the Council is no longer able to provide core funding to Citizen's Advice Woking, it has agreed the following support package for 2024/2025:

- £10,000 funding to provide the Court Desk Service from the Homelessness Prevention Grant.
- £24,500 funding for the Ukrainian Hub and Syrian and Afghan Refugee Support.
- £30,000 funding from UK Shared Prosperity Fund to support the transition to a new business model.

- £50,000 from the Council's proposed Hardship Fund for the delivery of a Hardship co-ordination package.
- To continue to allow CAW to use office space at Provincial House, which has a rateable value of £41,250.
- To continue to cover £69k for services charges.
- To provide up to £4,210 in discretionary business rates relief.

In relation to the Hardship co-ordination package, the full details are still being scoped, but high-level objectives are likely to include:

- Supporting volunteers from CAW to continue to provide advice services (related to debt, money management, employment etc) within their new business model.
- Working with partners and community groups to identify and map the range of hardship support services available across Woking, to produce a comprehensive directory.
- Delivering an "Advice First Aid" approach to upskill volunteers within faith and community groups to expand knowledge locally of the range of services that customers can be signposted to.
- Actively signposting clients to a range of providers of hardship support.
- Facilitating a network of hardship support providers across Woking, bringing together the variety of voluntary, community and faith organisations, and ensuring that information is shared and voluntary capacity maximised.
- Monitor the impacts of the increased Council tax and gaps in service provision, building community capacity where required.

CAW will identify a lead contact to oversee the delivery, but the package will be delivered by multiple staff and volunteers. It is anticipated that the outcomes of this package will be two-fold – supporting residents immediately with advice services whilst also strengthening the wider support offer in Woking so that it is sustainable and can continue to assist residents in future years.

2. Services which will no longer be delivered

The current Service Level Agreement requires Citizens Advice Woking (CAW) to:

- Provide Woking residents with free, confidential, impartial, and independent advice on all areas of social law, as specified on the Citizens Advice Woking website.
- Provide the County Court Help Desk service.
- Deliver the Financial Capacity Programme.

CAW received over 6,700 customer contacts during 2022/23. The Centre holds the Advice Quality Standard (AQS) quality mark at general help with casework in welfare benefits and debt, and specialist level in housing.

Further statistics provided by CAW for April 2023 and September 2023;

- 63% of clients helped, stating they were disabled or have a long-term health condition.
- 20% of all clients with disability or long-term health condition also having mental health illness.

It is recognised that a reduction in the Council's core funding will reduce the level of service provision that CAW can provide.

3. Engagement and consultation

The Council has carried out public engagement on all proposed savings to ensure a balanced budget for the 2024/25 financial year.

The **first phase of the engagement** took place in **summer 2023**. Residents and businesses had the opportunity to have their say on how to tackle the budget shortfall. <u>View the report on the Woking Community Forum website</u>.

The second phase of the public engagement took place between 2 October and 12 November.

Residents and businesses had another opportunity to scrutinise the proposed savings and have their say.

This included a range of options for finding further budget savings, such as increasing Council Tax and making changes to the way services are delivered, which may mean reducing or withdrawing services, or indeed making revised charges or working with partner organisations. The outcome of this consultation will be reported to Council in January 2024, with a full Council decision on 8 February 2024. <u>View the consultation feedback</u>.

Specific stakeholder consultation took place with Citizens Advice Woking. Citizens Advice Woking responded to a specific stakeholder consultation survey and participated in meetings with the Leader of the Council, Chief Executive and Strategic Director for Communities. Citizens Advice Woking were also provided the opportunity to speak at the Overview and Scrutiny Commitee.
