Your Council Tax 2024/25

It has been almost a year since government intervened in Woking Borough Council and a Section 114 Notice was issued stopping all but essential spending due to our unprecedented financial challenges.

To tackle these challenges we must first start to live within our means.

This has meant making many difficult decisions. We will offer fewer day care services, public toilets are likely to close, and we will reduce the frequency of grass cutting in our parks and cleaning of our streets and public spaces.

We can no longer give grants to local charities and voluntary groups that offer invaluable services to residents and up to 60 council staff face redundancy.

We will also need to sell assets in a managed way over the next few years.

However, we listened to resident feedback and looked for solutions to save services. We have kept Pool in the Park open by offering fewer concessions and charging a little more. We have transferred delivery of some services to neighbouring councils, and in the future, community centres and sports pavilions will be managed by community groups.

We have found some funds for Citizens' Advice Woking and are grateful to Woking Community Transport for continuing some level of Bustler service.

In February we agreed to save £8.4 million, but our financial situation is so severe that we cannot deal with it on our own.

The council has accepted a government support package that will allow us to start tackling our £2.1 billion debt, which currently costs us £64 million a year in interest repayments alone, and set a balanced budget for the coming financial year.

This significant and unprecedented support will give us flexibility to deal with money that should have been put aside for borrowing and to capitalise our debt. The government considers that an increase in Woking Borough Council's proportion of Council Tax of up to 10% from April is appropriate and proportionate. For a Band D property this is 50p a week.

Any increase is difficult, so we are putting in place support for those who find it hard to pay rising household bills.

These critical decisions are ones I did not want to make. They are necessary if the council is to continue to provide essential services, set a balanced budget and begin to return Woking to long-term financial sustainability.

The future remains difficult and challenging. I am determined that Woking will recover to become a better council focused on delivering essential services to you.
