Globe House Lavender Park Road West Byfleet. PLAN/2020/0475/BC: Variation of Condition 3 of PLAN/2016/0990 (Extension of the existing Globe House to increase living space on existing apartments and to create 6no self contained flats (3no studio and 3no 1 bed units) with associated landscaping works (Amended Description) (Amended Plans)) to allow for internal changes to the ground floor cycle and waste storage facilities for the increase in size of one of the first floor flats.

*1 Lady Place Cottages Church Hill Pyrford. PLAN/2020/0466/DR: Erection of a two-storey rear extension.
*Newstead Hockering Road Woking. PLAN/2020/0504/BB: Demolition of existing garage and

adjoining utility room and erection of part two storey, part single storey side extension, two storey front extension and two and single storey rear extensions. Removal of tile hanging and use of render and cladding on external elevations. Replacement of windows and doors with white PVCu.

*Barncote Danes Hill Woking. PLAN/2020/0548/BB: Erection of a garden shed and air conditioning unit.

152 High Street Old Woking Woking. PLAN/2020/0538/BC: Proposed change of use from B1 Office to A1 use ground floor and C3 use first floor.

*Well Cottage, Hook Heath Road Woking. PLAN/2020/0550/BB: Erection of a single storey side and rear extension with skylight lantern.
*149 York Road Woking. PLAN/2020/0551/JK: Erection of a single storey side extension and

rear dormer. Alterations to external finishes and fenestration.
*Ferndale House 25 Ferndale Road Horsell. PLAN/2020/0557/BB: Addition of air conditioning condenser unit and associated pipe work to the southern end of the North East side elevation of the dwelling.

*16 Connaught Road Brookwood Woking. PLAN/2020/0581/GF: Erection of a two storey side extension and single storey rear extension. (Amendment to PLAN/2020/0142).

<u>A I M Aviation Henshalls Abbot Close Byfleet West Byfleet</u>. PLAN/2020/0509/BB: Change of use from Class B1/B2 (Business / General industrial) to Class B8 (Storage or distribution) and alterations to the external appearance of the building and service yards, including new fencing.

*East House Beech Hill Mayford Woking. PLAN/2020/0515/BB: Erection of two storey rear (north) extension and single storey side (east) extension, alterations to fenestration and external materials, construction of new pitched roof over existing two storey side projection (east) (to replace existing flat roof), removal of existing side dormer window and replacement with enlarged side dormer window (east), insertion of side rooflights (east) (above entrance hall), formation of new partial side dormer window (west) and erection of first floor infill extension (west) (with rooflight in flat roof over).

*Well Cottage, Hook Heath Road Woking. PLAN/2020/0550/BB: Erection of a single storey side and rear extension with skylight lantern.
