



## ROAD TRAFFIC REGULATIONS ACT 1984 – SECTION 14

### WOKING BOROUGH COUNCIL (STANLEY ROAD) (TEMPORARY ROAD CLOSURE) ORDER 2019

**NOTICE of a proposal to make a temporary traffic regulation order under section 14(1) of the Road Traffic Regulation Act 1984 and regulation 3 of the Road Traffic (Temporary Restrictions) Procedure Regulations 1992 (SI 1992/1215).**

- 1. WOKING BOROUGH COUNCIL as agent for SURREY COUNTY COUNCIL (being the Highway Authority)** gives notice that it has made an Order under section 14(1) of the RTRA 1984 and any other enabling powers over an area of the highway being Stanley Road, Woking shown red on the plan attached to the Order (“Plan”).
2. The Order closes one part of an area of the highway known as Stanley Road shown coloured red on the Plan.
3. The Order is needed to facilitate the reconstruction and resurfacing of part of Stanley Road using black asphalt to match the surfacing used within the town centre.
4. The Order came into operation on Monday 15 July at 12.01am and will be in force for a period of five weeks.
5. The Order restricts vehicular access to town centre through Stanley Road, for the above mentioned dates.
6. An alternative access route is available for use while the Order is in force. For southbound traffic (shown green on the Plan) from Stanley Road roundabout, turn left onto Walton Road, turn right onto Grove Road, turn right at the end onto Maybury Road and follow the one way system along The Broadway. For northbound traffic (shown blue on the Plan), from Maybury Road keep left onto The Broadway, turn right onto Duke Street, and follow the one way system onto Chertsey Road.
7. Access for pedestrians will be maintained at all times.
8. A copy of the draft Order and Plan may be inspected free of charge at Woking Borough Council, Civic Offices, Gloucester Square, Woking, Surrey GU21 6YL from 15 July 2019 until 25 August 2019 between 9.30am to 4.45pm, Monday to Friday (excluding bank holidays and public holidays).
